**Subject:-** FC Lease renewal for 221.80 hectares of forest land diverted for establishment of wind power project in favour of Karnataka Renewable Energy Development Limited (KREDAL) for sub lease to Enercon (India) Limited, presently Wind World (India) limited on BOT basis in District Chitradurga, Karnataka: Proposal No FP/KA/WIND/287146/2022 (Submitted on 05/08/2022)

Forest Proposal No FP/KP/WIND/34510/2018 (Submitted on 06/07/2018) & FP/KP/WIND/42832/2019 (submitted on 15/11/2019), proposal no FP/KA/WIND/43786/2020 (Submitted on 08/01/2020).

With reference to above, Forest Diversion for an area of 221.80 Ha was secured vide MOEF GOI Stage-II approval letter dated 2-04-2003, in favour of Karnataka Renewable Energy Development (KREDAL) -sub lease of Enercon (India) Limited, presently Wind World (India) limited in Chitradurga district of Karnataka. Subsequently, lease deed was executed between Forest department and WWIL, for a period of 15 years from 3-09-2003 to 2-09-2018. The lease was expired on to 2-09-2018.

Before the expiry of lease, we have applied for renewal of lease on 6-07-2018 by online submission of proposal (no FP/KA/Wind/34510/2018) and later revised applications were submitted to address the queries raised by Forest Dept (vide proposal no. FP/KA/Wind/34510/42832/2019 dt. 15-11-2019) and proposal (no FP/KA/Wind/43786/2020 dt. 9-01-2020). Subsequently, EDS was raised by Forest Dept for the proposal (no FP/KA/Wind/43786/2020) and in response it was advised to us for revising the proposal using detailed DGPS surveys for the entire project area i.e. 221.80 Ha.
