After ground verification there is slight changes in the figure of the area utilized for establishment of wind mills. Since the revised figure is unable to upload on the online portal PARIVESH, the proposal submitted earlier are hereby withdrawn and fresh proposal no. FP/KA/WIND/43786/2020 is uploaded on Parivesh portal for approval.

You are requested to kindly consider the same and action may be taken at the earliest to approve the lease renewal.
