Sub: Request for the permission for laying of underground Gas Pipeline of 12" Dia Steel Pipe and 125mm Dia MDPE Pipe of M/s Indraprastha Gas Limited from Ch. 79.100 (RHS) to Ch. 92.300 (RHS) and across the National Highways at 03 number of locations. The total section length from ROW applied is 13.20km on along National Highways (Delhi-Muzaffarnagar Road), NH-58 (New NH-334) in the State of Uttar Pradesh.

Sir,

Based on your recommendation, the approval for permission for laying of underground Gas Pipeline of 12" Dia Steel Pipe and 125mm Dia MDPE Pipe of M/s Indraprastha Gas Limited from Ch. 79.100 (RHS) to Ch. 92.300 (RHS) and across the National Highways at 03 number of locations. The total section length from ROW applied is 13.20km on along National Highways (Delhi-Muzaffarnagar Road), NH-58 (New NH-334) in the State of Uttar Pradesh is accorded by the Competent Authority with directions to follow the guidelines issued vide MoRT&H Circular No. RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016. Further, Competent Authority has authorized Project Director on behalf of NHAI for signing of License Agreement with the Applicant under intimation to this office.

The above approval is subject to ensure the compliance of following conditions before according permission:-

- The aforesaid NOC is being issued upon the successful realization of the requisite fee in "Bharat Kosh" as confirmed/verified by PD-Meerut vide his letter No. D-21326 dt. 11.02.2021.
- Enclosed Bank Guarantee bearing No. LOBG201012001444 issued on 21.03.2020, valid upto 18.03.2021 amounting to Rs. 1,00,10,000.00 issued by IDFC First Bank has been expired on 18.03.2021. Hence, before issuance of NOC to the instant proposal, it is requested to obtain extended BG from the applicant for further one year.
- The crossing/laying will be done as per the proposed/agreed location route and as per proposed layout plan.
- The Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.

- (v) Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
- (vi) Undertaking to the following effect may be taken from the applicant and made part of the agreement:-
- Three copies of "As Laid Drawings" of utilities (Hard and Soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.
 - The permission may be terminated immediately on violation of the agreed terms & conditions.
 - The execution of the proposal by the Applicant would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound manner prescribed by NHAI.
 - Ensure that the submitted Agreement is in prescribed format as per Ministry circular No. Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 for execution with the applicant, and BG be obtained as per the Circular.
 - Work programme from the Applicant may be obtained and ensure timely completion.
 - The compliance of various undertakings given by the Applicant may be ensured before and after signing of License Agreement, as the case may be in the interest of safety of road users and NHAI.
- (vii) Laying/crossing work should be carried out through HDD method only.
- (viii) It shall be the responsibility of the Applicant to ensure the Safety and maneuverability of Highway Traffic during laying of Gas Pipe line.
- (ix) The approval is based on the submissions made by the Applicant as verified by the PD, PIU-Meerut. The Applicant is responsible for the details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
- (x) In view of any future development requiring necessary alteration, including complete removal or shifting of the Gas Pipe line, the same shall be carried out by the Applicant at its own cost to the satisfaction the Highway Administrator.
- (xi) In case of violation of the norms of Ministry's Guidelines, the NOC automatically stand withdrawn.
- (xii) IRC: 98-2011 be complied wherever applicable.
