## HARY Terms and conditions

- 1. The applicants shall maintain good house keeping both within factory and in the premises. All hose pipelines values, storage tanks etc. shall be leak proof. In plant allowable pollutants levels, if specified by State Board should be met strictly.
- 2. The applicant/company shall comply with and carry out directive/orders issued by the Board in this consent order at all subsequent times without negligence of his /its part. The applicant/company shall be liable for such legal action against him as per provision of the law/act in case of violation of any order/directives. Issued at any time and or non compliance of the terms and conditions of his consent order.
- 3. The applicant shall make an application for grant of consent at least 90 days before the date of expiry of this consent.
- 4. Necessary fee as prescribed for obtaining renewal consent shall be paid by the applicant along with the consent application.
- 5. If due to any technological improvement or otherwise this Board is of opinion that all or any of the conditions referred to above required variation (including the change of any control equipment either in whole or in part) this Board shall after giving the applicant an opportunity of being heard vary all or such condition and there upon the applicant shall be bound to comply with the conditions so varied.
- 6. The industry shall provide adequate arrangement for fighting the accidental leakages, discharge of any pollutants gas/liquids from the vessels, mechanical equipment etc. which are likely to cause environment pollution.
- 7. The industry shall comply noise pollution (Regulation and control) Rules, 2000.
- 8. The industry shall comply all the direction/Rules/Instructions as may be issued by the MOEF/CPCB/HSPCB from time to time.
- 9. The industry shall ensure that various characteristics of the effluents remain within the tolerance limits as specified in EPA Standard and as amended from time to time and at no time

the concentration of any characteristics should exceed these limits for discharge.

- 10. The industry would immediately submit the revised application to the Board in the event of any change in the raw material in process, mode of treatment/discharge of effluent. In case of change of process at any stage during the consent period, the industry shall submit fresh consent application alongwith the consent to operate fee, if found due, which may be on any account and that shall be paid by the industry and the industry would immediately submit the consent application to the Board in the event of any change during the year in the raw material, quantity, quality of the effluent, mode of discharge, treatment facilities etc.
- 11. The officer/official of the Board shall reserve the right to access for the inspection of the industry in connection with the various process and the treatment facilities. The consent to operate is subject to review by the Board at any time.
- 12. Permissible limits for any pollutants mentioned in the consent to operate order should not exceed the concentration permitted in the effluent by the Board.
- 13. The industry shall pay the balance fee, in case it is found due from the industry at any time later on.
- 14. If the industry fails to adhere to any of the conditions of this consent to operate order, the consent to operate so granted shall automatically lapse.
- 15. If the industry is closed temporarily at its own, they shall inform the Board and obtain permission before restart of the unit.
- 16. The industry shall comply all the Directions/ Rules/Instructions issued from time to time by the Board.

## **Specific Conditions:**

- 1. The unit will comply conditions of both ECs granted for this project by the SEIAA as per the EIA notification dated 14.09.2006 (amended till date).
- 2. The proposed project will conduct Air & water Quality Monitoring and Preservation in mining lease & surrounding area as per ECs granted for the project.
- 3. The proposed project will conduct Noise and Vibration Monitoring and also take necessary Prevention measures for necessary compliance.
- 4. The proposed project will strictly follow the approved Mining Plan.
- 5. The proposed project will make Land Reclamation & develop proper green belt as per project ECs.
- 6. The Unit will regularly operate proper and adequate PCD.
- 7.Unit will comply with notification /guidelines/norms issued by any competent authority.
- 8. The unit will take permission from competent authority for ground water extraction.
- 9. The unit will use only HSPCB approved fuel.
- 10. The unit will submit fresh air emission analysis with 90 days of grant of this CTO.
- 11. With the approval of this CTO expansion, the previously granted CTO No.
- HSPCB/Consent/: 313100421CRDCTO8086368 Dated:26/08/2021 & No. HSPCB/Consent/: 313100423CRDCTO43353066 Dated:01/09/2023 will be deemed null and void.
- 12. CTO expansion is granted for total production enhancement from 5.6 MTPA to 9 MTPA without addition of the land.
