

पहुंच मार्ग हेतु उपयुक्तता प्रमाण पत्र

संस्थान श्री बंजरंग पावर एण्ड इस्पात लिमिटेड द्वारा वन परिक्षेत्र छोटेडोंगर अंतर्गत खनिपट्टा एवं खान पहुंच मार्ग के लिए वन भूमि व्यपवर्तन हेतु आवेदन प्रस्तुत किया गया है। आवेदक संस्थान द्वारा खनिपट्टा क्षेत्र में पहुंचने हेतु तीन वैकल्पिक रास्ते प्रस्तुत किये गये हैं। संस्थान द्वारा खान क्षेत्र में पहुंचने हेतु मुख्य रूप से 9.020 हेक्टेयर क्षेत्र जो कि वन कक्ष क्रमांक - पी 2217 ए, पी 2226ए, 2182, 2181, 2180, 2184, 2183 एवं 2188 से होकर जाता है का चयन किया गया है। आवेदित खनिपट्टा क्षेत्र एवं पहुंच मार्ग सहित आस पास का संपूर्ण क्षेत्र पूर्ण रूप से वन भूमि एवं दुर्गम पहाड़ी क्षेत्र के अंतर्गत आता है। संस्थान द्वारा मुख्य रूप से जिस मार्ग का चयन किया गया है उक्त क्षेत्र में वृक्षों की संख्या अन्य क्षेत्र की तुलना में कम है साथ ही भूमि समतल एवं दुर्गम पहाड़ी क्षेत्र नहीं है। उक्त पहुंच मार्ग का पूर्व से ही ग्रामीणों द्वारा उपयोग किया जा रहा है। संस्थान द्वारा आवेदित क्षेत्र वन क्षेत्र के अंतर्गत आता है तथा यह मार्ग ग्राम पेरमापाल एवं ग्राम मड़मनार को मुख्य मार्ग से जोड़ता है।

अतः यह प्रमाणित किया जाता है अन्य किसी भी विकल्पों की तुलना में संस्थान द्वारा प्रस्तुत किये गये पहुंच मार्ग 9.020 हेक्ट. में वृक्षों की संख्या, भूमि की संरचना एवं सुगमता के अनुसार उक्त पहुंच मार्ग की सर्वाधिक उत्तम एवं उपयुक्त है।

**NOTE FOR JUSTIFICATION OF APPROACH ROAD OUT OF DIFFERENT
ALTERNATIVES**

M/s Shri Bajrang Power & Ispat Ltd has been allotted a Mining Lease over an area of 57.00 hectares in forest compartment number:- 252,267,268 & 269 in Chhotedongar Forest Range of Narayanpur Forest Division in Narayanpur District, Chhatisgarh.

As there is no direct approach to the Mining Lease area, the applicant company studied alternate roads supposed to be constructed to get approach to the allotted area both for transportation and transmission.

Alternate Road – 1: This road will be the road that is used occasionally by the public. The distance of the road is 9.02 Kms comprising 9.02 Hectares of area. This road will join the main road in between Dhanora and Madamnar.

Alternate Road – 2: This road will be the road that is used by Chhotedongar and Badgaon village people occasionally. The distance of the road is 10.80 Kms comprising area of 10.80 hectares .

Alternate Road – 3: This road will be the road that is used by Chhotedongar and Chameli village people occasionally. The distance of the road is 10.90 Kms comprising area of 10.90 hectares.

After studying the above three alternatives, it is proposed to go with the shortest distance road that is 9.02 KMs over an area of 9.02 hectares which is the Alternate -1

DETAIL ANALYSIS OF ALTERNATE ROADS

Three alternate options were considered to develop the approach road for the applied Mining Lease Area. After analysing the best suitable option was considered and was applied for approval. The detail comparison

As observed from the above table, the Alternate – 1 seems to be suitable and is with minimum length (9.02 KM) and with sparse vegetation .

Hence, the forest land involve in Alternate – 1 is unavoidable and necessary to access the Mining Lease from the State Highway for movement of mining related equipment and transporting trucks.
