



Enclosed please find herewith photocopy of Notification No. Home (A) B (1)10/2015 dated 27.2.2018 received from the Principal Secretary (Home) to the Govt. of Himachal Pradesh, Shimla-171002, on the subject cited above.

2. In this regard it is int mated that the Govt. of Himachal Pradesh has withdrawn the notification/order of newly created/up-gradated Police Stations, Police Posts and Out Post with immediate effect. Police Station, Police Post and Out Post wise detail is as under:-

In continuation to this office Order Endst No. 2-99/15-17-108736-78 Dated 29.9.17, vide which Temporary Police Post Thural upgraded as full-fledged Police Station along with creation of 13 Nos Police officials staff i.e. SI/1, ASI/1, HC/1 Consts/10, Cooking and Sweeping work from out Source under the jurisdiction of Sub Division Jaisinghpur District Kangra HP.

Now in pursuance of HP. Govt. Notification No. Home- (A) B (1) 10/2015 Dated Shimla 27.2.2018 received through PHQ letter No. P-II (1) Misc/2018-7741-49 Dated 15.3.2018 vide which the Govt. of Himachal Pradesh has been withdrawn the notification of newly up-graded Temporary Police Post Thural as Police Station along with 13 Posts of Police Officials i.e. SI/1, ASI/1, HC/1 Consts/10, Cooking and Sweeping work from out Source.

Therefore now Police Station Thural will function as Temporary Police Post Thural falling under the jurisdiction of Police Station Lambagoan with effect from 23rd March, 2018 as per past practice. The notification received from HP. Govt. vide Govt. HP Notification No. Home (A)B(1)-3/2016 Dated 29.9.17 vide which Panchyats and Villages under these 13 Panchyats earlier supplied Police Station Thural stand merged in Temporary Police Post Thural under the jurisdiction of Police Station Lambagoan. In view of above necessary correspondence, if any may be made in the name of Incharge Police Post Thural from the above said date.
