- 2) Operation and Maintenance of the complete works and supply of surface water to 85 villages of Block Moga-1/Baghapurana/Nihal Singh Wala District Moga, for a period of 120 months state of Punjab, India.

With reference to subject cited matter and letter under reference, as desired by your office, NOC is issued from Dhilwan to Channu Wala link road under conditions stated below :-

Conditions for cutting Metalled road / Berm.

1. Water supply pipeline will be laid on the edges of ROW of roads. Laying water supply pipeline at berms may be avoided.
2. This office will be informed before laying down the pipelines and monthly schedule of work will be given.
3. Not more than half Kilometer road should be cut for laying water supply pipeline, Next portion should be cut after restoring the already cut portion.
4. Cutting of metalled road should be avoided. If needed, department should be informed before cutting the road.
5. In case, metalled road is cut, it should be restored immediately after completion of work as per PWD specifications.
6. During laying of water supply pipeline, safe traffic handling will be responsibility of your department.
7. It should be kept in mind that while laying water supply pipeline, no public or government property is damaged. In case of damage, cost of damage will be paid by your department.

Other conditions :

1. If water supply pipeline is laid in Forest Area then this department has no objection. But if separate approval is needed from the Forest Department then it will be taken at your level from that department.
2. If NOC is required from any other department during laying of water supply pipeline, then it will be taken at your level.

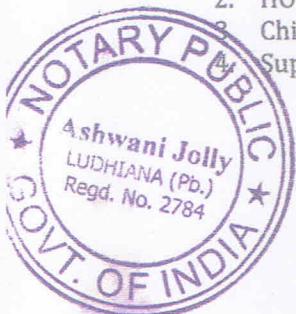

Sir / Madam,

With reference to subject cited above, NOC is issued according to conditions stated below :

1. According to MORTH Letter No - RW/NH-33044/29/2015S&R(R) dated 22-11-2016 (copy enclosed), lease money of Rs 7661/- for a period of 5 years and Performance Bank Guarantee for one year of Rs 1,35,700/- should be deposited. Your department will make an agreement with our department according to MORTH letter. Pipeline should be laid according to specifications given in above mentioned letter .
2. Specifications of MORTH to be followed during Earth excavation and road repair or restoration will be responsibility your department . If any damage is caused to road due to pipeline leakage then its responsibility will be of your department.
3. This pipeline should be laid at the end of ROW of forest land. No manhole should be constructed in ROW . If any pipeline comes across the road while widening the road, it should be replaced at your departments cost.
4. Getting NOC from Forest Division department / Panchayat / Nagar Council , etc will be yours .
5. Depth of road crossing pipe should be of minimum 2 metres.
6. During laying of water supply pipeline, safe traffic handling will be responsibility of your department.
7. If any damage is caused to bridge / culvert / road during laying or after laying pipeline, responsibility to repair will be of your department .
8. Village Khote, Patto Jawahar Singh Wala, Patto Hira Singh Wala and Khai being populated area , there is a provision of Bridge. Pipeline should be laid keeping in view the design of fly over bridge.

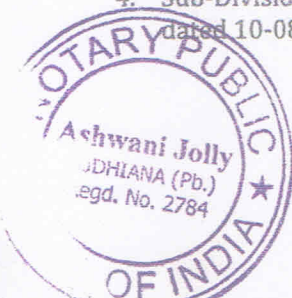
