In compliance of the Ministry of Environment and Forest (MoEF), Government of India letter No. 11-9/98-FC(pt), dated.3.08.2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated.05.08.2013 wherein MoEF issued certain relaxation in respect of linear project, it is certified that 54.00 Ha of forest lands proposed to be diverted in favour of Executive Engineer, NH Division, Vijayawada for Rehabilitation and Upgradation of NH 565 form Km 133.922 to 154.900 to Two land paved shoulders in the State of Andhra Pradesh under NHDP-IV in Guntur District which passes through Kunkuduchettupenta, H/o Mittamedapalli; Siluvakonda and Davupalli Villages in Veldurthy Mandal. It is further certified that,

- a) The process of identification and settlement of rights under the Forest Rights Act, 2006 has been carried out for the entire stretch of NH 565 from KM 132.922 to KM 154.900 through Davupalli RF proposed for diversion was completed.
- b) The Grama Sabhas were conducted in Kunkuduchettupenta and Davupalli Villages and explained on the proposed developmental project i.e., widening of NH 565 from KM 132.922 to KM 154.900 through Davupalli RF as per Section 3(2) of Forest Rights Act.2006 and the Grama Sabha extended its consent vide resolutions Nos.15 & 23, dated. 05.07.2021 respectively subject to payment of compensation for the Forest Rights over agriculture land and land to land for residential plots granted to them and under their enjoyment.
- c) The NH 565 line passes through Kunkuduchettupenta, H/o Mittamedapalli Village, Siluvakonda and Davupalli Villages in Veldurthy Mandal. The present proposals involve the recognized Forest Rights of primitive tribal groups and pre-agricultural communities. The rights of 23 tribals (of which 20 are PTGs i.e., Chechus) on agriculture land granted under RoFR Act is getting affected. Also, the rights of 18 individuals(of which 10 are PTGs i.e., Chechus; 4 are STs (Sugali) and 4 are BCs) on House sites granted under RoFR Act is getting affected, besides 2 drinking water bore wells & 1 bore well with motor getting affected.

Compensation should be provided along with R&R scheme as per the provisions in Section 41, 42 & Sl. No.1 of Schedule 2 of RFCT LA R&R Act, 30 of 2013 read with Rule 24 & 28 APRFCT LA R&R Rules, 2014.
