Reply of the observations raised on the Proposal No. FP/RJ/WATER/10622/2015 for diversion of Forest land of size 0.1435 Hectare near Ramdwara for construction of OHSR & laying of pipeline to provide water supply facility in municipal area Tonk under Rajasthan Urban Infrastructure Development Project is as under:

- 1) Earlier diversion of Forest land in District Tonk was done by the Forest Department in favour of PHED for construction of Bisalpur Dam. Copy of that permission is uploaded in the end of proposal in Additional Information Detail.
- 2) Authorization letter issued by the Chief Engineer, PHED, Rajasthan, Jaipur to authorize Executive Engineer, PHED, Tonk for submitting and uploading the proposal for diversion of Forest land is uploaded on website.
- 3) For laying of water supply line, sewer line, STP, construction of OHSR (overhead Service Reservoir) etc., approx. 68.00 hectare Non forest land is required under RUIDP project for town Tonk.
- 4) Statement showing the detail of forest/ non forest land required for different work like OHSR, Rising Main, Distribution Main, Sewer Line etc. is uploaded in the section of Additional Information Detail.
- 5) Kml file has modified by showing the detail of works like rising main, distribution main, OHSR etc. and uploaded on website. Boundary of Forest land has shown in separate drawing and uploaded in the section of Additional Information Detail.
- 6) Detail of the OHSR, Rising Main, and Distribution Main has shown in the G.T. sheet and modified GT sheet has uploaded. Certified copy by competent officer and drawing showing the boundary of Forest land has uploaded in the section of Additional Information Detail.
- 7) A map prepared using Total Station showing the latitude & longitude of the proposed land along with Forest Boundary has uploaded in C-(iv). Certified copy has uploaded in the section of Additional Information Detail.
- 8) Process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) has done and certificate issued by the District Collector, Tonk in FORM-I along with No Objection Certificate issued by the Nagar Parishad Tonk is uploaded.

- 9) Information uploaded in point "L" has corrected and a map has uploaded that showing the detail of works proposed on non forest land.
- 10) Source for the proposal is Bisalpur dam. Transmission Work from Bisalpur dam to Tonk is proposed under separate project. A map showing the Bisalpur dam and transmission work detail is uploaded in the section of Additional Information Detail.
- 11) Forest boundary has shown in the separate drawing and uploaded in the section of Additional Information Detail.
- 12) Copy of Administrative & Financial Sanction, Technical Section, Brief Note of the proposal and other information's have uploaded in the section of Additional Information Detail.

It is requested to please issue the permission for diversion of forest land of 0.1435 hectare for construction of OHSR, laying of distribution & rising main.
