The proposal for diversion of 401.7824 ha. of additional Forest land within the mining lease of Gandhamardan (Block-A) Iron Ore Mines of M/s. OMC Ltd. has been received through online from the Addl. Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, FC Act. O/o the Principal Chief Conservator of Forests, Odisha, Bhubaneswar vide No. FP/OR/MIN/13031/2015 bearing State Sl. No.OR-046/2015 on dated 05.06.2015. The said proposal in 5 sets is sent herewith after due scrutinization for approval under section-2(ii) of Forest Conservation Act, 1980 (Amended) over 401.7824 ha forest land including 7.2807 ha of safety zone.

## A. Brief description of the Project Proposal

## A.1. Brief description of the Project

Mining Lease was granted for a period of 30 years in the name of Gandhamardan (Block-A) Iron Mines in favour of M/s Odisha Mining Corporation (OMC) Limited for exploration of Iron ore over an area of 618.5760 ha. in the revenue villages of Suakati & Daonra and Gandhamardan Proposed Reserved Forest under Banspal Tahasil of Keonjhar District, Odisha vide letter No.III(A)M-11/13 dated.21.05.1963, Mining and Geology Department, Govt. of Odisha (Copy enclosed as Annexure- I). The First Renewal of Mining Lease has been applied for Iron ore over 618.5760 ha on dated 04.04.1992 i.e., one year prior to the expiry of the lease and the second renewal has been applied on dated 01.05.2012.

The total mining lease area of Gandhamardan (Block-A) Iron Ore Mines of M/s. OMC Ltd. is 618.5760 ha which involves 486.1340 ha Proposed Reserved Forest, 33.6132 ha Village Forest, 85.5772 ha Non-forest Govt. land & 13.2516 ha Non-forest Tenant land. The M.L. area is located within latitude 21° 36'08.58286"N to 21° 37'41.89734"N and longitude 85° 29'13.06230" E to 85° 31'16.78336" E of survey of India Topo sheet No. 73 G/6 and 73 G/10. The northern ML boundary of Gandhamardan Block-A Iron Ore Mines of M/s OMC Ltd is common with the southern boundary of Gandhamardan Block-B Iron Ore Mines of M/s OMC Ltd.

The total forest land involved in the mining lease is 519.7472 ha. The forest land broken prior to 1980 is 64.7242 ha (57.3327 ha PRF and 7.3915 ha Village Forest). The lessee has obtained in-principle approval under sec- 2(ii) of FC Act, 1980 vide F. No. 8-105/2006-FC dated.17.02.2009 of MoEF, Govt. of India over 117.9648 ha (Virgin PRF-76.7206 ha + Pre-80 broken up- 41.2442 ha). The balance forest land over 401.7824 ha (Virgin PRF- 352.0807 ha, Virgin VF-26.2217 ha and 23.48 ha pre-1980 broken up forest land) has been applied for approval under sec- 2(ii) of FC Act, 1980.

The annual production capacity of the mines is 0.35 MTPA of Iron ore. The mineable reserve is computed at 3,97,74,618.00 tonne of Iron ore. The project will generate direct employment for more than 377 people and indirect employment for 2000 people to achieve the targeted production.

The present proposal has been applied by the lessee in compliance with the order of the Hon'ble Supreme Court of India in I.A. No. 3402 of 2012. The said order is enclosed vide **Annexure-XV**, Page No. 132 to 138 in the Diversion Proposal for kind reference.

## A.2. Physiography and Geological formation

The mining project of M/s OMC Ltd is situated in the central part of Keonjhar popularly designated as Bhuyan- Juang Pirh (BJP), which is famous for quartzite and lava deposits. This geological formation is an integral part of Western mountainous terrain containing lofty hills with intervening narrow vallies. This area is densely forested and represented by high hills namely Gandhamardan I (Δ 1090 mtr.), Gandhamardan II (Δ 1062 mtr.) and Gonasika (Δ 1009 mtr.) etc. The rocks of Keonjhar District belong to the iron ore series of the Dharwars, an exceedingly ancient system of archaean rocks, which also occurs in neighbouring Singbhum and Sundargarh Districts. This mass gives passage after a short distance south of Keonjhar boundary to rocks of Gandawana system, to Archaean rocks (Khondalite and charnockite) at its west, southwest and to quaternary rocks at its southeast. Shale, phyllites, sehists, sandstone, conglomerates and quartzite occur often with extensive basic intrusion. Most part of this district is covered by rocks of Iron ore group represented by BHJ, BHQ & BMQ which provides the iron ore deposits.

The quartzites are normally seen on the hilltops extending roughly in north-south direction to west of Keonjhar. The quartzite is underlain by pyrophyllite, which forms economic deposits at some places. This is in tern underlain by weathered Keonjhar granite. At times, on the top of the weathered granite, china clay pockets are available. On the further west, trap and tuffites are seen. White to yellowish lithomarge is also seen associated with traps. Buxites with intercalated laterite cap over metavolcanics on the flat-topped hill of Dholkota pahar near Kuanr, about 30 K.M west of Keonjhar has been reported with reserve of 10 million tons with Al2O3% up to 49. Dolerite dykes and basic intrusive are also seen in this central area. Due to the availability of quartz sericite schist and amphibolite predominantly in this area, better agricultural lands are found in Telkoi and Banspal.

## A.3. Floristic-Faunal Composition

The applied forest land is a part of Gandhmadan PRF which comes under the type 3C/C<sub>2e</sub> Moist Peninsular Low Level Sal. The prevailing forest growth comprises the sal forests of Bhuyan & Juang Pirh plateau and extends over a large area. The main associates of sal are *Pterocarpus marsupium*, Terminalia alata, Emblica officinalis, Bridelia retusa, Gmelina arborea, Cleistanthus collinus, Careya arboria, Diospyrus melanoxylon, Butea parviflora, Woodfordia fruiticosa, Zyziphus spp. The main climbers associated with sal in these areas are Combretum decandrum, Butea superba, Bahunia vahlii, Smilax tetraphylla etc. The important grass species are Heteropogon contortus, Aplida mutica, Dicanthium carricosum, Cynodon dactylon, Chrysopogon aciculatus etc.

The moist peninsular low level sal occurs on crystalline rocks with yellow loam soil. The present canopy density varies from 0.3 to 0.4. The quality of sal is of Q IV. It is mainly due to shifting cultivation and human interferences.

Regeneration of sal is not up to mark. At places, it is patchy. The established crops come mainly from the coppice origin. The proportion of established regeneration varies considerably. The failure of regeneration from seed origin is due to absence of mother trees. However, in some blocks like Bayakumutia, Gonasika, Samakoi, Saleikena-Siriabahal-Kalapokhari, Mundula etc. the regeneration is normal.

No rare or endangered flora& fauna is noticed in this area but however, movement of mega fauna like elephant is often noticed in the fringe area. The area comes under the elephant habitat zone-2 of ORSAC, Bhubaneswar.

The lessee has obtained in-principle approval under sec- 2(ii) of FC Act, 1980 vide F. No. 8-105/2006-FC dated.17.02.2009 of MoEF, Govt. of India over 117.9648 ha (Virgin PRF-76.7206 ha + Pre-80 broken up- 41.2442 ha). The balance forest land over 401.7824 ha (Virgin PRF- 352.0807 ha, Virgin VF-26.2217 ha and 23.48 ha pre-1980 broken up forest land) has been applied for approval under sec- 2(ii) of FC Act, 1980. #### **B.4.** Tree Enumeration.

There are 297 nos. of sound, 11538 Nos. of unsound trees and 248 Nos. of poles below 30 cm girth enumerated in the 26 nos. of representative sample plots @2.00 ha per sample plot within the virgin area of 378.3024 ha. of the Mining Lease. In addition, there are 42 nos. of sound, 1449 Nos. of unsound trees and 250 Nos. of poles below 30 cm girth in the broken up forest land over 23.48 ha included in the instant proposal. The species wise and diameter class wise abstract of enumerated trees in respect of virgin and broken up land in separate sheets is enclosed as **Annexure** – XXICB).

## B.5. Cost benefit analysis.

The Cost Benefit analysis has been worked out as per the guide lines of Forest (Conservation) Act, 1980 and enclosed in the proposal as Annexure-XXI(A)The Cost Benefit ratio is 1:13.60

#### B.6. Re-settlement and Rehabilitation.

The project does not involve displacement of any human habitation.

## **B.7. Safety Zone**

The total mining lease area of Gandhamardan (Block-A) Iron Ore Mines of M/s. OMC Ltd. is 618.5760 ha which involves 486.1340 ha Proposed Reserved Forest, 33.6132 ha Village Forest, 85.5772 ha Non-forest Govt. land & 13.2516 ha Non-forest Tenant land. The total Safety Zone of the mining lease is 21.43 ha. The forest land located in the safety zone is 7.2807 ha and non-forest land located in the safety zone of the mining lease is 14.1493 ha. The northern boundary of Gandhamardan (Block-A) Iron Mines is common with southern boundary of Gandhamardan (Block-B) Iron Mines of M/s OMC Ltd. The safety zone area has been demarcated with 4 feet height RCC pillars. In pursuance of the prevailing guideline of MoEF&CC, Govt. of India on demarcation, protection and regeneration of safety zone, the lessee has demarcated the safety zone all along the mining lease boundary as depicted above as per Safety Zone Plan (Copy enclosed as Plate-Viì). The lessee has deposited an amount of Rs. 96,38,100.00/- towards the cost of fencing & regeneration of safety zone and Rs. 13,55,600.00/- towards the cost of afforestation on one and half time of degraded forest land selected in Atei Reserved Forest under Ghatagaon Range. Fencing & Regeneration have not been taken up as on date. The lessee has undertaken to ensure management of safety zone in the mining lease as stipulated vide F. No. 11-125/2014-FC dated 04.07.2014 of MoEF&CC, Govt. of India. The said under taking is enclosed herewith as Annexure- xxxx (A).

#### B.8. Phased Reclamation Plan.

Earlier mined out area has not been reclaimed. Reclamation will be carried out, after exhaustion of the mined out area as per mining plan. In this regards the User Agency has furnished an undertaking vide Annexure-xxxx.

It is mentioned that the prepared DGPS map suffers from the following discrepancies which was also intimated during submission of DGPS map over 117.9648 ha forest land.

## Discrepancies in the prepared DGPS Map.

A. VF Plot No. 1028 & 1030 - The area of Plot No. 1028 included in the Mining Lease is 13.0852 ha as per authenticated land schedule and the status of the plot is Village Forest. However, an area over 4.088 ha of the same plot has been shown embedded in Gandhamardan PRF.

Similarly, the area of Plot No. 1030 included in the Mining Lease is 6.6848 ha as per authenticated land schedule and the status of the plot is Village Forest. However, an area over 3.725 ha of the same plot has been shown embedded in Gandhamardan PRF.

This fact has been depicted in the DGPS Map.

- B. Spatial extent of Gandhamardan PRF- The extent of Gandhamardan PRF shown in the DGPS Map in the North-East comer is not in consonance with the notified PRF Map. However, the same is in agreement with that of the authenticated Village Sheet No. 3 of Suakati Village.
- C. Typological Error- The part of mining lease shown as Doanra PRF may kindly be read as Gandhamardan PRF.

The total forest land involved in the mining lease is 519.7472 ha. In-principle approval under FC Act, 1980 has been accorded over 117.9648 ha and non-forest Govt. Land over 117.9648 ha has been allotted for Compensatory Afforestation against the diversion of 117.9648 ha forest land in compliance with condition No. 1 (i) of Stage-I approval vide F.No.8-105/2006-FC Dated 17.02.2009 of MoEF, Govt. of India and the same land has been mutated in favour of State Forest Department. In the instant 2<sup>nd</sup> RML diversion proposal, Non-forest Govt. land to the tune of 329.7743 ha (519.7472 ha

been identified and allotted over an area of 329.811 ha in village Khamarpadar under Thuamulrampur Tahasil vide letter No.737/Rev dt. 30.04.2013 of Collector, Kalahandi for Compensatory Afforestation. The copy of the allotment letter is enclosed as Annexure —XXIX. Compensatory Afforestation scheme in respect of aforementioned Non-forest land is enclosed herewith.

The total forest land involved in the mining lease is 519.7472 ha. NPV of Rs.46,19,25,521/- over entire forest land has been realised @Rs. 5,80,000.00 per ha over 64.7242 ha pre-1980 broken up forest land of canopy density- 0.1, Rs. 9,20,000.00 per ha over 151.6375 ha virgin forest land of canopy density- 0.4, Rs. 7,30,000.00 per ha over 303.3855 ha virgin forest land of canopy density- 0.35 and the differential amount of NPV of Rs. 6,34,07,570/- over 303.3855 ha demanded at the revised canopy density of 0.4 @Rs. 9,39,000 per ha.

# C.3. Wild Life Management- Site Specific Wildlife Conservation Plan and Regional Wildlife Management Plan.

The area does not form part of any National Park, Wild Life Sanctuary, Biosphere Reserve. It also does not come under any wild life corridor. But, there is movement of wild elephants often noticed in the fringe area. In this regard, a Comprehensive Site Specific Wildlife conservation Plan has been prepared and duly approved by PCCF (WL)& CWLW, Odisha with a total financial out lay of Rs. 629.83 lakhs out of which the user agency has deposited Rs. 516.69 Lakhs on dated 14.02.2013 for the activities to be implemented by Forest Department in the project impact area.

The lessee has deposited an amount Rs. 2,65,98,768/- (1,23,71,520/- dt. 14.02.2013 and Rs. 1,42,27,248/- dt. 03.12.2013) through RTGS towards the cost of Regional Wildlife Management Plan @43,000/- per ha over 618.576 ha of ML area. The lessee has furnished an undertaking to bear the differential cost towards Regional Wildlife Management Plan (Copy enclosed as Annexure-XXXXA).
