UNDERTAKING

We do hereby undertake the following for furtherance of the forest diversion proposal over 401.7824 ha of forest area pertaining to Gandhamardan Block-A Iron Ore Mines of M/s Odisha Mining Corporation Limited:

1. To bear the cost of compensatory afforestation and/or penal compensatory afforestation.
2. To bear the cost of fencing, protection and regeneration of the safety zone.
3. To bear the cost of afforestation in the safety zone area of the ML and over 1.5 times of the safety zone area in degraded forest elsewhere.
4. Deposited the cost of Net Present Value (NPV) of the total forest land included within the ML. The differential amount shall also to be paid if the rate is revised up wards.
5. To reclaim the disturbed area at our cost as per the phased reclamation plan.
6. To dispose of unsystematic waste dumps and rearrange them in the specifically earmarked dump yards in benches with boulder wall fencing to prevent wash down of the waste dump.
7. To maintain permanent pillars with serial numbers posted as per the existing land use plan demarcating the broken up area as well as the Renewal of the Mining Lease (RML) area.
