

I wish to state that TWAD Board, Major Project Division, Coimbatore is executing the water supply scheme to the 2 added areas of Coimbatore Corporation, i.e (Kurichi and Kuniyamuthur) since 2018. As a part of the Water Supply scheme, pipelines of various diameter needs to be laid in the Pillayarpuram Hillock area.

As this area belongs to Tamilnadu Forest Department, We have Applied to the forest department for permission. While analyzing the proposal, the District forest officer, Coimbatore has instructed TWAD board to produce the details showing the extent of land required in each forest Block. The entire forest land in the pillayarpuram area has been divided into 3 blocks. The SF numbers comprised in each blocks are as follows,

S.No	Forest Block No	SF no Details
1	Block Part I	5, 6/1A, 6/2A, 6/2B, 7, 12, 13, 14 15, 16
2	Block Part II	4/3
3	Block Part III	25/3

In this regard, it is kindly requested to carryout survey in above SF numbers and provide us the report indicating extent of area covered in each SF number at the earliest for further processing the proposal with forest department. The plan showing GIS mapping of the proposed pipe line alignment in the forest land is enclosed herewith for reference.

I wish to state that, with respect to the reference letter 1st cited above, a requisition letter has been ^{sent} submitted by the Assistant Executive Engineer, TWAD Board, Major Project Sub Division, Kuniamuthur - requesting to carryout survey in the Pillayarapuram Hillock area for collecting certain particulars.
