Ltd., Admn. Office- 1-41, DLF, Industrial Area, Phase-I, Fridabad-121003(HR) for the execution of above project subject to the following conditions:-

- 1. The firm shall enter into legal agreement with the department by signing an agreement with Executive Engineer, I&PH division Padhar.
- 2. All the conditions of the agreement so signed shall be strictly adhered to by both parties.
- That the Chief Engineer (MZ) IPH Department Mandi shall be the sole adjudicator of any dispute arising during construction as well as subsequently and his decision shall be binding on the parties.
- In case, there is any scarcity of water due to drought or any reasons, the requirement of department shall have precedence over the requirement of this project.
- 5. The firm shall ensure that the quantum of minimum flow of water to be released and maintained throughout the year immediately downstream of the diversion site is a threshold value of not less that 15% of the minimum inflow observed in the lean season to the main river water body whose water is being harnessed by this project. The firm shall also ensure adequate minimum environmental flow in the river below the diversion site to take care of aquatic life and ecology of the area.
- 6. The firm shall rehabilitate/ repair/ compensate for the IPH assets/water resource as well as Private Kuhals/Irrigation schemes/Water Supply Scheme in case these are damaged or adversely affected due to construction of the project. During restoration period the arrangement for providing of water to beneficiaries shall be made through tankers and other alternative possible arrangement by the firm.
- Additional water requirement of the department in future in addition to the project demand will get priority over the requirement of the firm.
- In addition to IPH Department requirement, the firm will also satisfy the requirement of private users, if any.
- 9. That the department will have liberty to draw water from Thaltukhod Nallah (Upstream and downstream) for construction of any new water supply and irrigation schemes as and when required in future and if any schemes, source of water up and downstream the HEP get affected the executing agency will have to deposit the original cost of the scheme including

its remodeling and restoration, augmentation cost, as the case may be with the department in advance so as to make these facilities available to inhabitants of affected areas for which the company well have no objection.
