In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purpose read with MoEF's letter dated 5<sup>th</sup> February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 0.497 hectares of forest land proposed to be diverted in favour of POWERGRID Medinipur Jeerat Transmission Ltd., Eastern Regional-II Headquaters for the purpose of construction of Loop Out of 400 kV D/C Chanditala – Kharagpur Transmission Line at 765/400kV Midnapore Sub-station in Paschim Medinipur district falls within jurisdiction of Paltigarh (Plot No. 790) & Akmura (Plot No. 438) village(s) in Keshpur tehsils.

It is further certified that :

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.497 hectares of forest area proposed for diversion. The proposed area does not cover any part of the FRA 2006 since there is no any claim in this area as on date.
