subject is being issued on the following terms and conditions :-

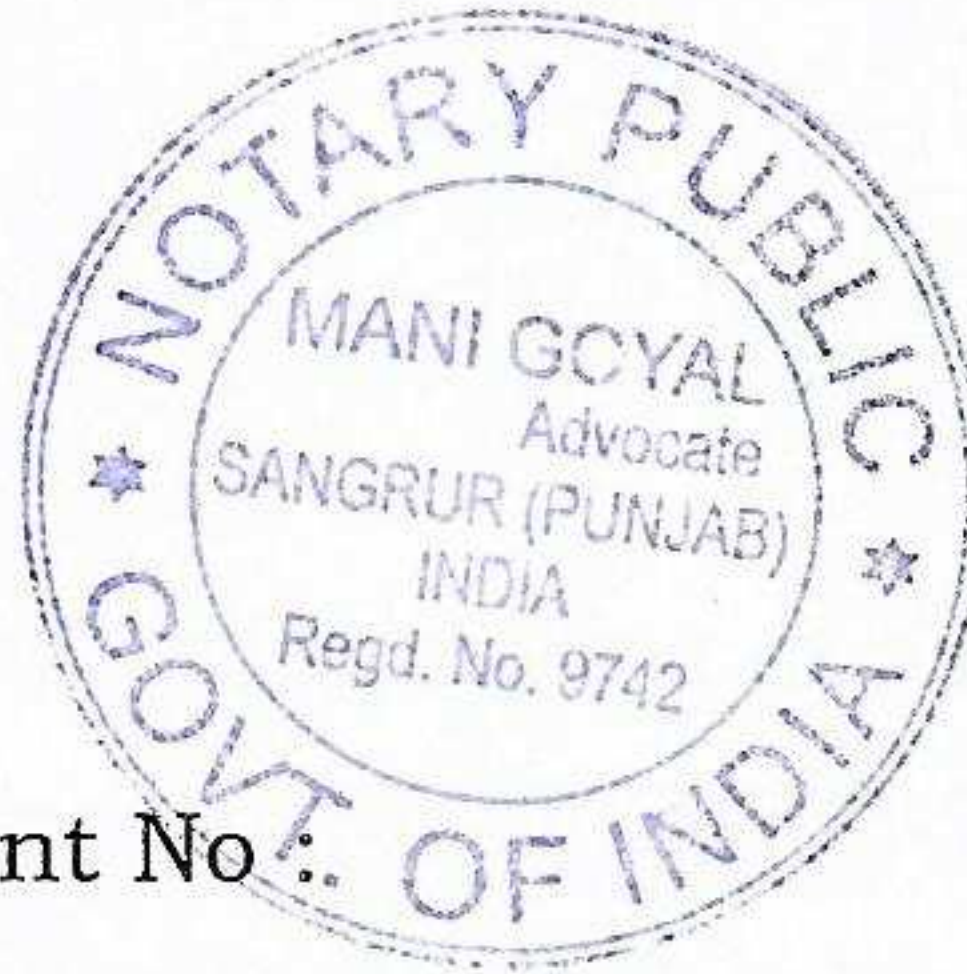
1. Construction to be made as per attached approved plan.
2. Following the rules of Schedule Act 1995, the last foundation of the building (meaning without encroaching the Government land) be made after securing 30 Meters of own possessed land from road and no construction should be made upto 30 Meters of road.
3. Drainage arrangement should be made for proper disposal of water, so the road may not be damaged by any means.
4. No wastage should be thrown on road side.
5. No parking should be made on the road side.
6. If in future the road is required to be widen, then earlier construction made by you will be demolished by yourself, and no claim will be entertained.
7. If the instruction passed by the Government are violated then issued NOC will be treated as cancelled and the

construction thereon will be demolished at your own expenses, for which you will be fully responsible.
