Please refer to your office letter u/r (i) forwarding therewith the proposal/application seeking access permission for proposed Retail Outlet of IOCL on NH-131A at Km Ch. 40+100 (LHS) on plot No:- 1803,1807 khata No:- 316, Vill (Mauza)- Rautara, Dist.- Katihar in state of Bihar.

2. Vide Gazette Notification No. S.O. 3293(E) dated 16.09.2019, Regional Officer- NHAI has been made Competent Authority for granting permission (for access to the National Highways) for fuel station on sections entrusted to NHAI. Earlier Regional Officer, MoRTH was the Competent Authority also for the stretches entrusted to NHAI.

3. The proposal has been examined in light of NHAI's SOP dated 06.01.2020 and MORTH's circular no. RW/NH-33032/01/2017-S&R(R) dated 26.06.2020. Following has been observed:

- (i) The processing fee of Rs. 10,000 (Rs. Ten Thousands) has been deposited through Bharatkosh.gov.in with transaction ref no. 0908190004052 dated 09.08.2019.
- (ii) In case of instant proposal, the proposal in hard copy with all relevant documents & drawings was submitted to PD, PIU-Purnea, NHAI vide IOCL's letter u/r (ii) who forwarded the proposal to this office vide letter u/r (i).  
PD, PIU-Purnea vide its letter u/r (i) has informed that the site has been inspected by the PD himself. PD, PIU-Purnea has also forwarded the checklist submitted by M/s IOCL and has recommended for grant of approval.


