A proposal has been received by this office from **Executive Engineer Irrigation Division P.M.G.S.Y. Rudraprayag** (for diversion under FCA-1980) of **2.7225 ha.** of forest land for non-forestry purpose. The project envisages the use of forest land for Construction of Kunjethi to Byunkhi Motor Road The site inspection of the land involved in the proposal has been done by me on dated **26-06-2019**.

On inspection of the site, it is found that the land required by the user agency is a RF / PF / un-classed / other forests measuring **2.7225 ha. (1.9996 ha. Village Forest Land + 0.7229 ha. Revenue Forest Land)**
