With reference to the subjected work, it is submitted that National Highways Authority of India, Ministry of Road Transport and highways, Govt. of India is working on UP-gradation and 4-lanning of Paonta Saheb-Ballupur (Dehradun) Section of NH-72 (Km 97.000 to Km 149.000) in the State of Uttarakhand and Himachal Pradesh. The project road is passing through forest area in the Sirmaur District. The minimum requirement of the forest land on this road is approximately 1.8916 Ha.

In this regard, it is requested to kindly issue certificate for the forest land proposed to be diverted on the project alignment, in respect to the Forest Rights Act 2006, certificate for Non-Availability of Non-Forest Land and a certificate of Non-Availability of Non-Forest land for Compensatory Afforestation in Sirmour District.
3. Drafts for FRA certificate, Non-Availability of Non-Forest Land certificate, and certificate of Non-Availability of Non-Forest land for Compensatory Afforestation along with village list and area statement is attached as Annexure-I for your ready reference & necessary action please.
