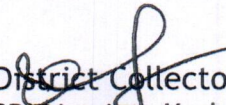

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter no.11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 (*FRA, for short) on the forest land, proposed to diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 0.76 hectare of forest land proposed to be diverted in favour of National Highways of India for widening and improving of the existing road to 2 laning of Rayachoty to Vempalli section NH-440 YSR District falls within jurisdiction of Lakshmipuram village H/o Surabhi of Chakrayapeta Mandal of YSR District.

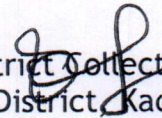
It is further certified that:
