Sub:- Diversion of 52.9666 ha. of forest land on 25 years lease basis to Hindalco Industries Ltd. for laying of 132 KV Electric Transmission Line from Renuagar to Hindalco in District Sonbhadra.

Sir,

I am directed to refer to your letter No.24967/14-2-95-800(27)/1995 dated 4.8.95 on the above mentioned subject seeking prior approval of the Central Government in accordance with Section-2 of the Forest (Conservation) Act, 1980.

After careful consideration of the proposal of the State Government, the Central Government hereby agrees in principle for diversion of 52.9666 ha. of forest land on 25 years lease basis to Hindalco Industries Ltd. for laying of 132 KV Electric Transmission Line from Renuagar to Hindalco in District Sonbhadra, subject to fulfilment of following conditions:-

"The user agency will transfer the cost of compensatory afforestation (revised as on date to incorporate existing wage structure) over degraded forest land twice in extent of area being diverted in favour of the Forest Department."

After receipt of compliance report on the fulfilment of the above condition from the State Government, formal approval will be issued in this regard under Section-2 of the Forest
