CLARIFICATION REGARDING ADMINISTRATIVE APPROVAL/FINANCIAL APPROVAL

In this regard in reply to point No. 2 it is submitted that temporary Police Post Thural started functioning on 15-07-1997 and was then upgraded to a Police Station on 01-10-2017. Then on 23-03-2018 Police Station was denotified and reverted back to a Police Post.

It is pertinent to mention here that Police Post Thural is temporary only for the purpose of Posting of personnel at the Police Post from existing strength of District Kangra Police. Although a staff of Assistant Sub Inspector=1, Head Constable C=01, Constable=5, Himachal Home Guard=02 is posted there on continuous basis. The Police Post has been functioning continuously for the past 22 years and is expected to remain functional in perpetuity.


It is further submitted that presently the Police Post is functioning from a rented building which is grossly insufficient for working of a Police Post. Further no other suitable rented accommodation or government building is available presently at Thural.

It is also submitted that a Police Post requires office space for atleast 10 persons alongwith waiting area. Also space for lock up, store room, armoury, barracks, kitchen and mess hall is required. Further some open space for storing impounded vehicles, excavators etc. and space for parade fall-in is also required. Hence transfer of 0.4253 hectare land for construction of Police Post Thural is justified

It is also submitted that administrative approval/financial approval for construction of building of Police Post Thural will only be granted by the competent authority after transfer of the aforesaid land in favour of Himachal Pradesh Police Department.
