- (i) The laying work will be done as per the proposed/agreed location route and as per proposed layout plan.
- (ii) The Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.
- (iii) Appropriate fees be levied for use of NH land for laying of utilities as per Ministry Circular No. RW /NH-330.44/29/2015/S&R(R) dated 22.11.2016.
- (iv) Undertaking to the following effect shall be submitted by the applicant and these will be part of the agreement.
- a. Three copies of "As Laid Drawings" of utilities ( Hard and Soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.
- b. The permission may be terminated immediately on violation of the agreed terms and conditions.

Please refer RO-Bhopal letter dated 02.06.2022, vide which the subject captioned proposal has been granted approval by the Competent Authority. i) Ensuring the safety of road users/public while laying the gas pipeline shall be the responsibility of the Applicant. Moreover, while laying of pipe line there shall be no hindrance to the Traffic Plying on NH and Incident (if any) occurs during the execution of the work, then the Agency owing to Pipe line laying will be held responsible and actions as stipulated in Control of National Highways (Land and Traffic) Act 2002 shall be initiated against the applicant including but not limited to cancellation of Granted Permission/ termination of the License Agreement and encashment of Performance Bank guarantee.

ii) Please ensure videography during the execution of the work and the same shall be compulsorily submitted to this office within 24 hrs. after completion of the work.


