The gradient of the road in some stretches is very steep as compared to proposal no. 1, also the numbers of trees are more i.e. 255 nos. and hence this alignment is rejected.
3.	Proposal No. 3(P-III) 3.680 kms forest length	2.20 ha	251	This alignment i.e proposal no. 03 comes out to be 8.480 kms, its length is 0.480 kms more than the proposal no. 1 including Shamlat & Private land. The gradient of the road in some stretches is very steep as compared to proposal no. 01 and 02, also the numbers of trees are more i.e. 251 nos. and hence this alignment is rejected.


Keeping in view, the above details, the proposal no. 01 is hereby accepted and is not liable to get changed at all in the near future.


