3. Plantation Model:

(a) Compensatory afforestation over an area of 7.30 ha of degraded forest land proposed to be raised. The area selected for this purpose in **Bhatrundi DPF** which is degraded forest area & has been notified as a land bank. Presently the area supports scattered deodar and Kail & Chil trees. The area identified for plantation has also been shown on the attached map. Plants @ 1100 plants per hectare will planted. The plantation will be raised in the following years after the approval of FCA proposal and further maintenance and beating up of failure will be done for the subsequent ten years. The scheme will be implemented by Forest Department through DFO Chamba. The cost structure of scheme is attached. The scheme has been formulated by taking into consideration the present wage rate Rs. 200/- and 10% cost escalation after first year has been provided. Total financial outlay for compensatory plantation scheme is Rs.1683195/- Certificate of DFO Chamba regarding suitability of area identified for compensatory plantation is attached. The area selected for compensatory plantation will be approachable Chamba-Nakrot-Charda road and the monitoring will be done as per existing monitoring mechanism in the forest department at present and also as per GOI instructions.

1. Technical Details:

Technical Details of Compensatory afforestation Scheme are as follows:-

- (a) General Details: an area of 7.30 hec will be taken up for planting under compensatory afforestation scheme in Bhatrundi DPF The area will be protected by barbed wire fencing and a mixture of conifer and board leaved species will be planted.1100 plants will be planted per heatare.
- (b) Spacement: 3.00 Mtr x 2.5Mtr.
- (c) Species : Deo, Ban and other broad leaved.
- (d) Plantation Method: Nursery grown one & half year above old plants (in Polythene bags as well as naked root) will be planted in 30x30x30 cm and 45x45x45 cm pits in the selected area. Bush cutting will be done in the infested area. The plantation will be maintained for subsequent 10 years in which beating up of failures will be done. The plantation will be rainfed.
- e) Soil and Moisture Conservation: -
- (a) Protection (Fencing, watchman, people's participation etc.): Area will be protected from grazing by erecting barbed wire fencing at all vulnerable places around the plantation. Further watch and ward as also fire protection will be ensured through regular departmental staff.
- (b) Proposed Monitoring Mechanism: The plantation will be monitored as per existing monitoring mechanism by GOI representatives as per instruction. The plantation site will be approachable.
