In this context, the Power Evacuation Plan for the Pharari Small Hydro Electric Project(SHEP) entails the laying of a 33 kV underground transmission cable in joint mode with the Hamshu-1 SHEP, extending up to the 33/220 kV Phojal Substation of HPPTCL. 

Subject: - Evacuation arrangement for Pharari (2 MW) HEP


Sir:

Approved evacuation arrangement for Pharari HEP envisages construction of 33 kV S/C line in joint mode with Hamsu-I HEP to 33/220 kV Phojal substation of HPPTCL.. IPP vide his letter dated 12.12.2017 (copy enclosed) has requested to evacuate power of Pharari HEP by laying 33 kV underground cable instead of overhead line. IPP's proposal to evacuate power by laying 33 kV underground cable is technically in order and accordingly TEC of the Pharari HEP may be amended by replacing the word "33 kV line" by "33 kV line/underground cable" please.
