- Before start the work this office may be informed in advance in written & a permission letter with instruction will be issued by this office. After issuance of permission letter from the Deptt. work could be started.
- The back filling of earth i/c watering, rolling, compacting, re-handling completed layer wise as per PWD specification of trenches shall be done by tamping and consolidation to ensure that the backfilling does not suffer any shrinkage in monsoon. The left out earth, if any shall be deposited out.

- You shall be bound to follow the instruction laid in circular issued by 5 the head office Chandigarh vide his memo No. 6551-620/General dt.11/07/2012.
- During execution proper precaution & commence of traffic road user 6 should be adopted at site by you.
- If the up-gradation of the existing road is required in future, or as and 7 when required by the Deptt. the laid OFC shall be dismantled without assigning any notice to the you and no claim in this regard shall be entertained & the same should be shifted by you on your cost.
