

# Joint inspection of HPPWD Road by Committee Constituted by HP State Government.

Name of Work: - Construction of link road Kiari to Khinna 0/0 to 7/705 Km. for obtaining sanction under FCA 1980 as per terms of reference of committee mentioned in the Principal Secretary (Forests) to the Govt. of HP Notification dated 30-06-2014.

In pursuance to the notification issued by Principal Secretary (Forests) to the Govt. of HP vide no. FFE-B-F (3)-31/2012 dated 24-10-2013 (Constituted vide judgment of the Hon'ble High Court of Himachal Pradesh in CWP No. 5600 of 2012 dated September 5/2013 titled Sh. Manoj Kumar S/o Sh. Shiv Charan Vs UIO and other linked with COPC No. 56 of 2009) the following committee constituted to inspect the work C/o link road Kiari to Khinna road Km 0/0 to 7/705 on dated 02-09-2018

The committee recommends that necessary approval under section 2 of the FCA, 1980 may kindly be accorded, for diversion of total 4.70 Hect. of forest Land.(Already used under Violation 1.85 Hect. and additional proposed Forest land 2.85Hect. required for completion of the road from Kiari to Khinna.)
