






The Pricipal Chief Conservator of Forests and Head of Forest Force has informed that, the Addl.prl.chief Conservator of Forests/CF, Rangareddy has submitted the processed proposal for Diversion of 1.9716 Ha (Revised from 2.293 Ha) of forest land in Shamshabad division for the Erection of 132KV DC/SC overhead line from 220/132 KV Fabcity to proposed 132/33 KV Kandukur Substation in favour of TSTRANSCO with due recommendation of Part - II by Forest Divisional Officer, Shamshabadn and the Part - III by Addl.prl.chief Conservator of Forests/CF, Rangareddy circle. Further stated that, the UA either has not submitted the ROFR certificate in FORM-I from the concerned District Collector for the subject proposal or the documentary evidences of DLC,SDLC, Gram Sabha etc. for forwarding the proposals to the Government. Hence, requested to issue RoFR certificate in prescribe format to submit along with the diversion proposals to the forest department.

Accordingly, the Sub Divisional Level Committee meeting is conducted where in it is unanimously passed resolution stating that there is no objection for diversion of 1.9716 Ha of Forest Land in Compt. No. 332 of Srinagar Reserve Forest in Mankhal Range for the erection of 132 KV DC/SC overhead lines from 220/132 KV Fab city to proposed 132/33 KV Kandukur substation in favour of TS TRANSCO, Hyderabad as there is no encroachment by the Tribal people in proposed forest land to be diverted and further, it is also resolved that there is no pending RoFR claims to be settled under the Forest rights Act and subsequent issue of certificate in Form-I.



In compliance of the ministry of environment and Forests (MoEF), Government of India's letter No.11-9/98-FC(pt) dated:03-08-2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated:5<sup>th</sup> February - 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that, 1.9716 Ha of Forest Land in Compt. No. 332 of Srinagar Reserve Forest in Mankhal Range for the erection of 132 KV DC/SC overhead lines from 220/132 KV Fab city to proposed 132/33 KV Kandukur substation proposed to be diverted in favour of TS TRANSCO, Hyderabad.

- a) The complete process for identification and settlement of rights under FRA has been carried out for the entire 1.9716 Ha of forest are proposed for diversion. 

