In reference to your office letter under reference, point wise compliance have been made as under:

- 1. This office has already been applied for withdraw the earlier project applied under "Thermal" on dated 09.02.2022. Further necessary action is to be taken by the Forest Authority.

- 3. Village wise breakup of the forest land have been made in Part-1
- 4. The work for "construction of water conveyance system and allied structure for supply of water to Gorakhpur Haryana Anu Vidut Pariyojna (NPCIL)" (i.e. IInd alternate) is a most important project of Govt. of India which is to be completed in the stipulated period. The tender have already been called and work allotted to the agency. To speed up the work, minimum 5 person is required in a length of approx. 1000 ft. The channel is to be constructed in a length of 36280 ft. After, completion of work, maintenance of channel is also required for 99 years for which approx. 6 number persons required during every supply in channel. So, keeping in view of above, approx. 120 number persons have been taken in this project.
