In context with the above subjected proposal, the replies to the EDS raised by Nodal Officer FCA communicated vide your above referred letter which pertain to the user agency are replied as under:


1. The complete details of the structures to be constructed and pipelines to be laid within the forest land for assessment of revised NPV as per MoEF & CC guidelines is as under:
