The Provisional NOC for the subject cited above is hereby given, subject to the following conditions:-

- That the Dwarika Educational Society will construct building alongwith its access as per 1. approved drawing at their own cost within 6 months of issue of provisional NOC as per clause 4.11 of IRC:12-2016. In case, the construction is not in months, provisional NOC shall be deemed to be cancelled unless renewed by the committee.
- 2. The Dwarika Educational Society will intimate the concerned Executive Engineer prior to the start of construction of the said Property that all compliance as per the requirement of the IRC guidelines has been done.
- 3. That after completion of construction as per approved drawings and other conditions of Provisional NOC, the *Dwarika Educational Society* shall apply for issuing final approval as per clause 4.11 of IRC:12-2016 to the Executive Engineer. At the time of applying final approval, the authorized representative of the oil company shall submit a certificate that he has inspected the site (duly mentioning the date of inspection) and the construction has been done as per approved drawings and other conditions of provisional NOC.
- That no puca structure will be constructed within the PWD land boundary. 4.
- That the natural profile of road land width will not be disturbed on account of this 5. proposed construction.
- The proper culvert/H.P culvert will be provided by owner on the approaches at his own cost 6. for cross drainage of water.
- There should be no inconvenience to the traffic for construction of approach road 7.
- Drainage / rain water from the above said manufacturing unit should not come on the 8. PWD road/ land.
- The approach road is to be allowed only through service lane & construction of which 9. (service road) is to be carried out by applicant and affidavit regarding the same has also been submitted by the applicant
- NOC from forest department will be required for construction of approach road. 10.
- The floor level of above said unit will be kept 9" down than the existing PWD road level. 11.
