Whereas, after extraction of tree growth the exact trees removed from the area will be estimated.


As per the said analysis on extrapolate, there are some trees species like *Acacia nilotica*, *Albizia Amara*, *Azadirachta Indica*, *Bambax malabaricum*, *Buchania latifolia*, *Canthium didymium*, *Cassia fistula*, *Dolichandrone crisper*, *Excoecaria agallocha*, *Ficus arnottiana*, *Gyrocarpus americanus*, *Lannea coromandelica*, *Lannea grandis*, *Peltophorum*, *Pongamia glabra*, *Pterocarpus santalinus*, *Rhamnus xylopyrus*, *Salacia chinensis*, *Terminalia chebula*, *Terminalia punctata*, *Ziziphus caracutta* etc., which have attained above 31 Cms. Girth class at breast height and the same are enumerated and statement showing the details is enclosed.

Further, There is one old Red Sander plantation in Ramapuram RF, Thimmasamudram Beat, Ragigunta Section, Srikalahasti Range part of the canal is passing through this plantation in Compt.No.228.




