5-1: A Proposal has been received by this office from अधिशासी अभियन्ता, पी०एम०जी०एस०वाई०, सिचाई खण्ड-1, नई टिहरी, जिला-टिहरी गढ़वाल for diversion under (FCA-1980) of 4.41 ha. of forest land non-forestry purpose. The project envisages the use of forest land for construction of राज्य योजना के अन्तर्गत जनपद टिहरी गढ़वाल के विकास खण्ड भिलंगना में मैगाधार-आली-सरुणा मोटर मार्ग का चौरा करखेडी, कोट, घणातगांव होते हुए चांजी तक विस्तारीकरण कार्य का स्टील गर्डर सेतु सहित नव निर्माण (लम्बाई-10.45 कि०मी०+2 न० सेतु)। The site inspection of the land involved in the proposal has done by me on date-03/08/2019.


