Subject: Regarding approval of layout plan for obtaining N.O.C. from the Forest Department.

Refer.: Your Letter No. 573 dated 29-01-2021 and Letter No. 1710 dated 22-02-2021.

In response to the subject and the letters under reference above NOC, a demand for the approved layout plan of roads of No. 4 was demanded by you for obtaining N.O.C. from the Forest Department. A road mentioned at Sr. No. 2 under letter referenced above falls under the jurisdiction of this division. Besides, this pipeline which starts from the point over the road described at Sr. No. 4, falls under jurisdiction of this division. But, the reach under which the whole pipeline is found, that area falls under the jurisdiction of the Forest Department. Therefore, as per you demand the approved plan and NOC of aforesaid 2 No. roads is being issued on the following conditions:-

1. As per layout plan, the pipeline should be found within 15 cm from ROW of the road.
2. The pipeline under any circumstances should not be laid down over the permanent road or berms.
3. Before commencing the work of laying pipelines, it should be informed to the concerned Sub Division Engineer of this office.
4. Your department will be bound to obtain a separate NOC, if required, from its own level from the Forest Department, Irrigation Department, Municipal Committee, Rajpura/ Ghanaur or from any other department.

Besides above, the rest of roads entered at Sr. No. 1 and 3 does not falls within jurisdiction of this division, the plans of these roads may be certified from the concerned department.
