PLACEMENT OF ONLINE INDENT THEREOF-REG**


Dear Sir,

1. Please refer 56 RCC letter No. 2010/LA FC/BG/88/E2 dated 14 Sep 2019 (**copy enclosed**).
2. It is intimated that construction of 60 Mtr single span Major Permanent Bridge (Chak Nallah) with PSC box Girder type superstructure at KM 7.525 over Kishan Ganga River on DNBCK Road is under progress by Project Beacon. This unit is in requirement of approx. 0.045 Ha (30 mtr x 15 mtr) forest land for construction of Niru side approach at said bridge location for which online indent has been processed on PARIVESH PORTAL.
