Subject: Recognition and vesting of Forest rights in accordance with the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right Act, 2006. (2 of 2007), regarding construction of office cum laboratory building at Maitra Ramban.

Reference: DFO Batote no. 2981-82/BFD dated 24/11/2020.

Sir,

In continuation to this office letter no. PCB/RDJ/Acetts/901-903 dated 25/02/2021, that Ministry of Environment, Forests & Climate Change (MoEF&CC) Government of India's letter no. 11-09-98-FC(pt.) dated 3rd August 2009, wherein the MoEF & CC has issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes & Others Traditional Forest Dwellers Act (Recognition of Forest Right) Act, 2006 (FRA) on the forest land proposed to be diverted for non-forest purposes.


In this regard, it is requested that **0.2 hectare (04 Kanals)** of Forest Land in compartment no. 40c/Btt (Batote Forest Range), with **Geo-reference 33° .13'.49"N, 75° .14'.55"E**, may be diverted in favour of **J&K Pollution Control Committee, Ramban** for construction of **Office cum Laboratory** building at **Maitra, Ramban** Jammu & Kashmir.

It is further, stated that there are already **three (03)** offices of Forest Department i.e. Office of the Divisional Forest Officer (DFO) Social Forestry Division- Ramban, Office of the Range Officer Wild Life Protection Range Batote - Ramban and Fire Control Room of Forest Protection Force and Forest Dept are functional near the proposed site as no other suitable site is available in Ramban.

Hence, it is requested to initiate the process of FRA 2006 and issue the certificate in the matter at the earliest.
