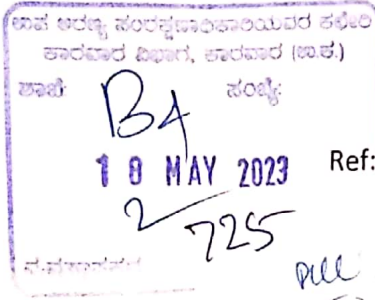

Adverting to the above, the Government of India, vide ref (1) have issued 'Final Approval' Stage-II on 18-11-2005 under Section-2 of Forest (Conservation) Act, 1980 for diversion of 3.846 ha. forest land in Block No. 10 of Navagadde F. Sy. No. 16A1A of Binaga, Sy. No. 1376 of Baad village, Ankola Taluka, Uttara Kannada district (Karwar Forest Division) for construction of GLSR Filter and Tunnels under combined water supply scheme in favour of Karnataka Urban Water Supply & Drainage Board (KUWS&DB), Kajubag, Karwar.
