



Subject: Regarding Meeting of DLC

Sir,

On the above cited subject, I am directed to refer to your office letter No. SLN/SDO(C)/SDK/2017-18-88 dated 17th February, 2018.

In this context, it is submitted that the case relating to M/S Friends Hlm Energies does not comes under the purview of Section 3(2) of the Schedules Tribe and Other Traditional Forest Dwellers Act, 2006 as the section 3(2) only meant for the 13 facilities inscribed therein which are managed by the Government which involve felling of trees not exceeding seventy-five trees per hectare.

It is further submitted that the case was placed before the District Level Committee for issuance of certificate that no forest rights/claims are involved on the land which is to be utilized for bringing up the facility, required for further processing the case under Forest Conservation Act, 1980. During the scrutiny of the case DLC observed that detail of the Khasra Nos has not been indicated/inscribed in the proceedings of SDLC as well as in the resolutions of concerned FRC & Mohal Sabhas.

Therefore, the District Level Committee, came to the conclusion that the case be returned to the Sub Divisional Officer (Civil) Salooni with the direction to resubmit the same after removal of anomalies.
