1. It is found that only maps are submitted, detailed comparative statement of all the alternatives
along with forest area involved, nos. of tree felling involved in each alternative alignment etc. shall
be submitted.

➤ All Three optional route and selective route prepared with considering the technical
parameters of transmission line. Final route has been selected on the base of minimum forest
area as well as minimum number of affected trees. Detailed bifurcation in the viewpoint of
forest area nos. of tree felling involved in each alternative alignment are as follows.


