Under Hazaribagh East Forest Division has been submitted in the website of Ministry of Environment, Forest and Climate Change on 09.11.2020 vide letter at reference (i). A site visit to inspect the land proposed here for diversion was carried out by DFO/Hazaribagh (E) with DFCCIL officials on 02.03.2021. Subsequently the following has been submitted from your end vide letter at reference (ii) that is replied as below:-

- 1. Temporary Pillaring has been done at site.
- 2. Fresh marking on trees has been done.
- 3. There are two plots involved in this forest proposal of Saraiya Khurd viz. Plot no. 53 for New Keshwari station yard and plot no. 54 for station building, staff quarter and station yard.
- 4. Layout Plan of the Project is attached.
- 5. Justification for location in forest that was submitted earlier is some as the justification that has been provided in other application for diversion of forest land that has been accepted by forest dept. Regarding utilization of the forest land in this proposal, the same is provided at (3) above. The location has been selected as it is for New Keshwari station of DFCCIL that is will be next to Keshwari station of Indian Railway.
