

**DETAIL NOTE ON THE PROJECT CONSTRUCTION OF HIMACHAL SANSKRIT
ACADEMY BUILDING AT MARHAVAG.**

The proposed construction of Building is falls in Gram Panchyat Shakrah, Development Block Mashobra, Sub-Tehsil Dhami, District Shimla, H.P. This building will attach the existing three blocks in E shape. The Himachal Sanskrit Academy facilitates the students and people of surrounding villages of Shimla District and also adjoining villages of Solan District.

At present only two rooms of Academy are in the office of Directorate of Higher Education. The Himachal Sanskrit Academy is continuously working for the promotion and spread of Sanskrit and is organizing Sanskrit conferences and seminars in every corner of the state. In the Academy building, a yoga workshop for learning yoga, a yagya for offering yagya and research on topics related to rituals and astrology is proposed to be constructed. The Himachal Sanskrit Academy will be taught practice of worship mode in the right way. The Hon'ble Chief Minister, Himachal Pradesh & President, Himachal Pradesh Sanskrit Academy has also desired to construct the Academy building immediately as he directed in Himachal Sanskrit Academy Mahasabha's Meeting held in 27-01-2017.


Therefore it is proposed that Academy building is constructed which will not only provide the better accommodation, better education for those peoples and students who are Sanskrit lovers and interested in Sanskrit. In the building of Academy, research work related to the planets and constellations will be done. The construction academy buildings will not only benefit the state but also many states of the country. Also during the construction of the said building employment of about 3000 man days is likely to be generated. Thus the population residing in the nearby villages will be benefited in various ways by the construction of the said Academy buildings.


During the survey work of the proposed building, maximum efforts were made to involve the minimum forest land but it was observed that there is no other alternate land is possible for the proposed building is in evitable to involve the forest land 1-14-22 hac. Comprising in Mauza Marhavag Khasra No. 160/1.

The benefits / facilities are many times more in comparison of the ill effects occurring from the constructions of the proposed Academy building. However all possible efforts / safe guards shall be made to minimize and mitigate any ill effects of the proposed construction the muck / debris likely to be produced during the construction shall be locally disposed/ dumped by filling the depressions of the ground to level it.

Accordingly the estimating amounting to Rs. 10 crore only has been framed by the Executive Engineer, HPPWD Division, Dhami. The estimate has been prepared to cover the portable cost of the work and is being submitted for obtaining technical sanction/ approval from the State Technical Agency. The stipulated period of the time for the completion of work is 3 months from the start of the work subject to availability of fund and approval of the estimate.
