- Forest Department will forward the proposal received as a special case since affected people are being displaced third time in last few years.
- Water Resources Department will provide the funds required to get the forest land de-reserved.
- If the proposal for diversion is cleared by the Forest Department and Government of India, Collector, Dungarpur will get the land allotment made on the basis of existing rules and regulations.

6. Allotment will be made by the Revenue machinery only after all the Court

cases are withdrawn.
