Query:1: C-(ii)-(a)- The uploaded patch wise KML files (drill site and approach road area) is inoperable. Upload the KML files against diversion area and the same may also be sent by email to the Nodal Officer (FC Act) Assam for ascertained the proposed forest area to be use for non-forestry purpose.

Query:2: H-(i)-(a)- A copy of the application seeking Environmental clearance may be uploaded along with its reference no and date of issue.

Query:3: I-(ii)-A copy of the application seeking Wildlife Clearance may be uploaded along with it reference no and date of issue.

- **The document for Wildlife Clearance shall be submitted as soon as the Forest Clearance proposal will be accepted, since Forest Clearance proposal number is mandatory for Wildlife Clearance application as per the MOEF &CC online portal.**

Query:4: K-(a)- FRA 2006 clearance certificate in prescribed format from the Deputy Commissioner of the concerned district has not been furnished. So furnished the same.

- **The FRA 2006 clearance certificate in prescribed format from the Deputy Commissioner has been obtained and uploaded a copy of the same on the MOEF &CC portal.**

Query:5: M-1-(i)-(c)- The uploaded document is a copy of Re-grant of petroleum mining lease for Dumduma PML measuring an area of 503.73 ha by Govt. of India and not a Letter of Intent (LOI) from Govt. of Assam. So Copy of Letter of Intent (LOI) may be uploaded.

Please note that, no mining activities will be allowed unless the full amount of 2% NPV for the forest area within the PML is realized by the State Government as instructed by Govt. of India, MoEF (Forest Conservation Division) vide their letter No. F. No. 8-118/2006 – FC dated 24th June, 2015.

- **The applicable amount of 2% against NPV towards forest land has been paid for Doomdooma PML area.**
