




STATEMENT SHOWING CERTIFICATES FROM A TO H
RELATING TO RECOGNITION OF FOREST RIGHTS ACT 2006

A	A letter from the State Government certifying that the complete process for identification and settlement of rights under the RoFR Act has been carried out for the entire forest area proposed for diversion, with a record of all consultations and meetings held.	The proposed area for diversion of forest land 595.331 Hectares of forest land for construction of Sri Balaji Reservoir & Mallemadugu Reservoir in Karakambadi RF, Krishnapuram RF, of WLM, Tirupati under Chittoor Dist does not fall in the Scheduled Tribes area and therefore does not attract the provisions of RoFR Act, 2006. Consequent on which, identification and settlement of rights under RoFR Act does not arise.
B	A letter from the State Government certifying that proposals for such diversion (with full details of the project and its implications, in vernacular / Local languages) have been placed before each concerned Gram Sabha of Forest-Dwellers, who are eligible under the RoFR Act.	There are no Forest Dwellers in the proposed diversion area, Hence, the question of placing the proposals before the Grama Sabha does not arise. However, the Grama Panchayats have passed resolutions stating that there is no objection for diversion of 595.331 Hectares of forest land for construction of Sri Balaji Reservoir & Mallemadugu Reservoir.
C	A letter from each of the concerned Gram Sabhas, indicating that all formalities / Processes under the RoFR Act have been carried out, and that they have given their consent to the proposed diversion and the compensatory and ameliorative measures if any, having understood the purposes and details of processed diversion	There are no claims under RoFR act with regard to the proposed area. Question of obtaining consent from the Grama Sabha does not arise. However Grama Sabhas were conducted at Chaitanyapuram, Krishnapuram and SU puram Grama Panchayats and they have given written statements stating that they have no objection for grant of permission for construction of Sri Balaji Reservoir & Mallemadugu Reservoir.
D	A letter from the State Government certifying that the diversion of forest land for facilities managed by the Government as required under Section 3(2) of the RoFR Act have been complied and that the Gram Sabha have consented to.	Since there are no claims under RoFR act with regard to the proposed area. However Grama Sabhas were conducted and no objections were received.
E	A letter from the State Government certifying that the discussions and decisions on such proposals had taken place only when there was a quorum of minimum 50% of members of the Gram Sabha presents.	Grama Sabhas were conducted with the villagers of Chaitanyapuram, Krishnapuram and SU puram Grama Panchayats. The villagers have not raised any objections for diversion of proposed area.
F	Obtaining the written consent or rejection of the Gram Sabha to the proposals.	The written consent of the Gram Sabhas of Chaitanyapuram, Krishnapuram and SU puram Grama Panchayats is enclosed. The Gram panchayats were also passed resolutions for no objection for diversion of proposed area.
G	A letter from the State Government certifying that the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable, have been specifically safeguarded as per the section 3(1) (e) of the RoFR Act.	Since there are no Primitive Tribal Groups and Pre-Agricultural Communities, existing in the proposed area for diversion, the protection of rights of such groups will not arise.
H	Any other aspect having bearing operationalization of the RoFR Act.	There are no other issues concerned with RoFR Act.
