
In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt.) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 740.885 Hectares (145.554 as Linear and 595.331 as Nonlinear) of forest land proposed to be diverted in favour of Chief Engineer NTRTGP Tirupati, Irrigation Department, Andhra Pradesh for "Construction of Sri Balaji Reservoir, Mallemadugu Reservoir & Kailasagiri canal under Galeru Nagari Sujala Sravanthi phase-II Scheme" falls under Krishnapuram RF, Karakambadi RF in in WLM Tirupati Range and Ramapuram RF, Nagalapuram RF in Chittoor East Division Range in Chittoor district out of which 595.331 Hectares of forest land for non-linear project i.e for Sri Balaji Reservoir & Mallemadugu Reservoir and the details are shown below:

It is further certified that :

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 595.331 Hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) and the District Level Committee are enclosed as annexure II
- (b) The proposal for such diversion (with full details of the project and its implications, in vernacular/ local language) have been placed before each concerned Gram Sabha of forest-dwellers, who eligible under the FRA;
- (c) The each of concerned Gram Sabha(s), has certified that all formalities/processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the gram sabha of 03 village(s) is enclosed as annexure II
- (g) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present;
- (h) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
- (i) The rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA.
