With reference to your above mentioned letter on the subject, it is to inform you that the road has been transferred from PWD to NHIDCL as per MoRTH letter No.NH-12037/254/2015/Misc./SARDP-NE dtd. 12/10/2015. It is therefore, reqused to approve the change of User Agency from PWD to NHIDCL as this road is to be constructed by the NHIDCL.

In addition to above, as desired vide your letter no. 3-ANC 071/2009-SHI/3822-23 dated 23/11/2016, additional CA area twice in extent of area to be diverted (7.33 ha X 2=14.66 ha) has already been identified & submitted to your office vide this office letter no.FOR 5-31/Cons/2008/1894-97 dtd. 21/12/2016. However, CA map in shape file with estimate to an amount of Rs.19,78,300/- for 14.66 ha plantation is again enclosed for your necessary action please.

In view of above, you are requested to approve the change of User Agency from PWD to NHIDCL and your decision may be communicated to enable this office to submit the compliance report for grant of Stage-II approval for diversion of additional area of 7.33 ha of forestland for disposal of muck.
