Sub: - Regarding Power Evacuation of (2 x 21 MW) Baggi HEP

Sir,

This is with reference to Transmission Part of DPR (Detailed Project Report) of Baggi HEP (2 X 21 MW) (Copy Enclosed) in receipt of HPPTCL for grant of TEC. BBMB vide their letter No.3995-97/CS/C-134/Vol-VI, dated-11.08.2021, (Copy Enclosed) have further clarified that the generation of the project is during lean period from 1st October to 20th April.

In this regard it is intimated that the Baggi HEP (2 x 41 MW) shall be evacuated by S/C LILO of Kangoo – Bajaura line subject to shifting of Malana-I HEP to 220/132 kV Charor Substation of HPPTCL.

It is further added that in case of any delay in shifting of Malana- I HEP to 220/132 kV Charor substation of HPPTCL, the power of the Baggi HEP shall be evacuated through the above arrangement with provision of SPS if required, as corridors for evacuation are expected to be relieved during the projected period of generation of Baggi HEP.
