

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

(For the forest land to be diverted under FCA)

A proposal has been received by the this office from मण्डलीय अभियन्ता, दूर संचार चरियोजना, सुरादाबाद से रामपुर - स्वार मार्ग पर मुख्य दूरभाष केंद्र रामपुर से डायमंड चौक तक (500 मीटर), राष्ट्रीय मार्ग संख्या 87 पर रामपुर जेल से बरेली गेट तक (500 मीटर) तथा राष्ट्रीय मार्ग सं- 24 (न्यू 530) के किमी 186 से किमी 214 (दूरी 28 किमी) कुल दूरी 29 किमी तक, 0.87 है० पर ओएफसीओ बिछाने हेतु diversion (under FCA-1980) of 0.87 hac. of forest land for non-forestry purpose. The project envisage the use of forest land for laying. The site inspection of the land involved in the proposal has been done by me on dated... 31.10.2017
