

महोदय,

उपरोक्त विषयक संदर्भित पत्र क्रम में लगायी गयी आपत्तियों का विन्दुवार आख्या निम्नवत है :-

1	The proposal falls under the category of non-site specific activity. Detailed justification for locating the project in the forest area giving details of the alternatives examined and reasons for their rejection has to be furnished. Therefore, the State Govt. is required to scrutinize the alternatives in more details and must give complete justification establishing its inescapability for locating the project in forest area as per guidelines para 1.15.	The college is to be constructed far from the village area in order to create a conducive environment for students to study. The land of Masi village is cultivable and therefore unable to acquire. Agriculture is the main occupation of the villagers of Masi. They run their life from agriculture. Further their land is near to riverbed and sensitive for construction. It is necessary to provide higher education to the children here. The location selected is the least affected by trees.
2	State Govt. is required to provide the details of all the components involved in the proposal at para B 2.4 i.e. component wise breakup, in part I online.	It is not possible to upload Revised description in online part I para B 2.4.
3	State Govt. may submit the layout plan depicting all the components of the project.	The layout plan Other information is already attached SL no-20 in online part I
4	FRA certificate of District Magistrate is required to be submitted and uploaded for non-linear category.	Non-linear category FRA is being submitted in online part I para K
5	State Govt. may submit the original copy of digital map proposed area.	The original copy of digital map proposed area of this office letter no 334/2019-2020 date 3-2-2020 has been submitted to the nodal office dehradun.
6	DFO has not mentioned his comments against para 5.5 in site Inspection Report (SIR). State govt. may submit/ upload the SIR of DFO mentioning comments against each para.	
7	State Govt. may submit the plantation scheme of 962 trees.	Estimate of 962 trees are attached in additional information SL no-44
8	It is seen from the MDP that 0.0413 ha of private land is identified for disposal of muck but the non-forest land required for the purpose has not been shown at para A-1 (ix), B-2.1, B-2.2, B-2.3 and B-2.4 of part I. State Government may submit clarification in this regard and provide full formation of non- forest land required in the proposal.	Nap land shown is only for the use of muck disposal. It is not to be acquired by the college. Therefore it is not possible to edit para A-1 (ix), B-2.1, B-2.2, B-2.3 and B-2.4 of part I.
