In this regard, I am directed to inform that Competent Authority has been pleased to approve the allocation of land measuring 25.506 hac at Master Plan Green, Sector – 29, Dwarka for compensatory afforestation under FCA 1980 as follows:

i. 15 Ha to NCRTC;

ii. 8.11 Ha to CPWD and

iii. 2.396 HA to Northern Railways

The allocation is proposed subject to the following conditions:

- 1. Ownership & Management of land shall remain with DDA.
- 2. The area under reference is bound to be developed as per the guidelines of the Hon'ble NGT and the plantation shall be done in accordance with the recommendation of Hon'ble NGT.
- 3. The user agency shall contact Forest Department for the amount to be deposited on account of compensatory plantation which will be calculated by Department of Forest & Wild Life, GNCTD and the calculated amount shall be paid by the user agency to the Forest Deptt.


